CALL MEETING TO ORDER: Mayor Johnston called the meeting to order at 6:30 p.m.

APPROVAL OF PURCHASE ORDERS: Discussed cutting spending and calling vendors to remove everyone except William and Dale on all accounts. Mayor Johnston made the motion to approve Purchase Orders seconded by Naugle. K.Sexton-yes, Ned Naugle-yes, D. Sexton-yes, VanBlaricom-yes, Lamson- yes, Johnston-yes. Motion carried.

1. WATER PLANT REPORT: Dale VanBlaricom distributed written report to Board Members. Water Plant is running well. 2 leaks were repaired. 2 purchases made for turbity meter and replaced lights at the Water Plant. Stated Tower Project is 98% complete and inspector will be here Tues. Waste Water Sewer guys will be back the first week in September to work on Lagoons and finish Sewer Project. Dale announce this is his one year anniversary and all levels are passing.

- 2. Discussion and possible approval for Mary Sweetin to move a trailer in at  $7^{th}$  and Grant St and providing water, sewer and trash services. Ms. Sweetin is not present. No vote.
- 3. Discussion and possible approval of Hatco Feed Store's sewer system, possibly being on a Septic System, and not charging sewer utility. Discussed the sewer crew did dye test for hatco and was not found going to the man hole that was replaced and hatco was told they could possibly have Septic.
